

## **DOREMI STANDARD HARDWARE PRODUCT WARRANTY**

Warranty Period: One (1) year from the date of invoice for the product purchased.

If you discover a defect in materials and/or workmanship, Doremi Cinema, LLC (“**Doremi**”) will, at its option, repair, replace, or refund the purchase price of this product at no charge to you, provided you return it during the warranty period, with transportation charges prepaid, to the authorized Doremi distributor from whom you purchased it or to any other authorized Doremi distributor within the country of original retail purchase. (You can obtain additional information by contacting Doremi at Doremi Cinema, LLC, 1020 Chestnut Street, Burbank, CA 91506). To each product returned for warranty service, please attach your name, address, telephone number, and a copy of the bill of sale bearing the appropriate Doremi serial numbers as proof of date of the original retail purchase.

If your product fails during the warranty period while you are out of the country of original retail purchase, you may have it repaired (no refunds or replacements are provided) at your expense by an authorized Doremi distributor in the country in which the product failed. You may obtain a refund for the repair costs by submitting a claim to Doremi (instructions are obtained by contacting Doremi at Doremi Cinema, LLC, 1020 Chestnut Street, Burbank, CA 91506).

This warranty applies only to hardware products manufactured by or for Doremi that can be identified by the “Doremi” trademark, trade name, or logo affixed on them. Doremi does not warrant any products that are not Doremi products. This warranty does not apply if (i) you and/or your customer(s)/assignee(s) utilizing the product has failed to abide by the terms and conditions of the Maintenance Manual posted on Doremi’s website at [www.doremi.com](http://www.doremi.com), the terms of which may be modified from time to time by Doremi in its sole and absolute discretion, and are included herein by this reference, (ii) the product has been damaged by accident, abuse, misuse, misapplication, faulty installation, unauthorized customer repairs, or damaged or further damaged caused by inadequate packaging when returning for repair, replacement or refund, (iii) the product has been modified without the written permission of Doremi, or (iv) any Doremi serial number has been removed or defaced.
